<u>Mayor's Liaison Update</u>: Emir Gur-Ravantab said the Mayor's vaccine mandate for businesses is ending at the end of the month which means restaurants will no longer need to check vaccination records. Masks mandates will also end at the end of the month but will not include schools, government buildings and a few other places. He reported that there are now Covid centers in all eight wards. Ward 3's location is at Chevy Chase Pavilion. He said budget season will be in the spring.

Jenny Wieroniey will step up to be president until the May elections. The NPS was invited due to recent complaints on the listserv about unleashed dogs at Battery Kemble Park. They said their first line of enforcement is EDUCATION. They will be patrolling more and informing dog walkers about the law which states that dogs must be on a leash at all times. They will be posting more signage as well and will be issuing citations soon. The dispatch number to call if you see dogs off leash and want to make a report is 202-610-7505. We also heard about a new program called Bark Rangers. Bark Rangers, who are trained volunteers, are akin to neighborhood watch volunteers but with dogs. They help the NPS enforce the law since the NPS can't be everywhere at once and is actually short staffed right now. District Department of Transportation (DDOT)

George and Karen were invited to talk about a bike lane proposal on Arizona Ave. from Loughboro to MacArthur. Before they went into specifics, they mentioned MoveDC which is a plan of all upcoming projects in DC for the next 25 years! It has a list of approved projects.

Regarding Arizona Avenue, they outlined three proposals and showed slides of what it would look like. Each plan includes a protected bike lane. They plan to have a stand-alone meeting in the spring and will send a "notice of intent" to the ANC once the final design is finished.

They also mentioned other projects that are in their list:

- Arizona Ave connection to CCT
- Dalecarlia Parkway Multiuse Path (on hold for now)
- New Mexico and Tunlaw widening the sidewalk
- Norton connection to the CCT (currently a dirt path)

They took many questions after their presentation.
